Admissions materials will not be evaluated until all relevant documentation has been received. After your admission materials are received CCFBC will notify the student regarding official acceptance within 30 business days.

## **Ministry Agreement**

(Local Attendance)

Ministry is a foundational experience to be prepared and equipped. Consequently, throughout your time at Shepherd School every student will be expected to participate in ministry in the following three areas

- I. Cross Christian Fellowship Ministry Assignments
- II. Shepherd School Ministry Assignments
- **III.** Special Events

I. Cross Christian Fellowship Ministry Assignments:

- A Shepherd School student is expected to serve two times a month at an assigned Cross Christian ministry
- Each Shepherd School student will serve at an assigned ministry for the duration of two quarters. Ministry assignments will rotate every two quarters
- Serving at additional Cross Christian ministries is optional, but cannot take the place of the assigned ministry
- During the summer months each Shepherd School Student is still expected to serve two times a month a Cross Christian ministry. However, this ministry will not be assigned as each student is expected to find placement at a Cross Christian ministry of their choice

II. Shepherd School Ministry Assignments

Each Shepherd School student will be assigned to ministries during the Shepherd School class time. The two ministry assignments are :

- 1. Set up/tear down and clean up
- 2. Food preparation for class breaks

Attendance and completion of homework assignments are also considered ministry and therefore are part of Shepherd School requirements. Failing to turn in written homework or participating in ministry could end in academic suspension and failure to graduate.
